Important Changes Regarding Delinquent Metro 3 Accounts

Effective October 15, 2024, delinquent accounts will be handled following new Colorado state rules.

At the March 2024 Metro 3 board meeting, the board approved a measure to turn over delinquent accounts more than 6 months behind and with a balance of \$360 or greater to Arapahoe County as a Special Tax Assessment on individual properties. The delinquent account amount would be added to the owner's property tax assessment. Additionally, a lien filing fee of \$275 would be billed to each account before it is handed over to the County. Finally, once added, the County will add a fee of up to 1.5% of the delinquent balance and a statutory penalty of 30%.

If you have an account that is delinquent and want to avoid this process, please contact the district manager, Shannon Torgerson, at Shannon.Torgerson@goodwin-co.com.

Payment plans can be set up with the District prior to the account being turned over. **The payment plan must be in place before October 15, 2024**. Payment plans will generally not be longer than 24 months and will cost the owner an additional \$25.00 per month.

Avoid these extra charges by paying your overdue amounts today!


Glenton Muller, Vice President
