METRO DISTRICT 3 UPDATE & SURVEY FEEDBACK

The Murphy Creek Metro District 3 Board and all Committees consist of resident volunteers. Additional services are provided by paid Contractors who report to the District Manager, Shannon Torgerson. Shannon reports to the Board and is an employee of Goodwin and Co., which specializes in the management of Metro Districts and HOAs.

2024 Recap

Metro District operations were busy last year. The tennis courts were resurfaced and painted with both pickleball lines and tennis lines, and pickleball nets were added. The pool experienced significant usage, the clubhouse increased community rentals, and the tot lots and native areas were well maintained, including snow removal. Additional improvements are planned in 2025.

Bond Update

One of the Board's major achievements was refinancing the District's bonds. These bonds originally paid for community infrastructure including roads, utilities, common areas, the Community Center, pool, etc. The bond refinance had a positive financial impact on all Metro District 3 property owners and decreased the tax mill levy by 20.087 mills. The mill levy is the "tax rate" that is applied to the assessed value of a property. One mill is one dollar per \$1,000 of assessed value.

Resident Survey Results

In October 2024, the Communication Committee conducted an online resident survey. This survey will be repeated annually to measure and compare resident satisfaction and concerns. The Board values your opinions. The full report is available online at murphy creek.org/news.

In summary, 47% of survey respondents were satisfied or very satisfied with our community. 28% were neutral and 20% were dissatisfied while 5% were very dissatisfied. People were positive about the school, the golf course, the walking paths, and their neighbors. The primary concerns were related to community traffic, vehicle speeds, and safety and security. The Metro District continues to work with the city of Aurora on traffic and speeding issues.

Safety & Security

Community safety continues to be a top priority in Murphy Creek. The Board contracts with Metropolitan District Public Safety (Metro Safety or MDPS) for services which include patrolling, monitoring, and maintenance of Metro District-owned security cameras and equipment, district-owned property emergency services, and cooperative and investigative services with the Aurora Police Department. The Board considers Metro Safety a valuable community resource. Research shows that communities with private safety services generally experience lower rates of crime than other communities.

Our contract with Metro Safety covers equipment purchases/monitoring/maintenance, and staffing. Here are the District's 2024 expenditures.

Security equipment purchases, monitoring, and maintenance	\$71,250
Metro Safety staff and emergency services	\$73,244

Metro Safety staff costs included hiring off-duty police officers to prevent disturbances (for example, patrolling during the July 4th weekend). Emergency services include actions to prevent damages to Murphy Creek Community Center (for example, due to the extensive freezing in 2023 that closed the building for costly repairs), repairing tennis court gates damaged by vandalism, etc.

Starting in 2025, the Communication Committee will share crime statistics through the district website and newsletter so the community knows what is being tracked by law enforcement within our neighborhood. This means we all need to report suspicious activities to Metro Safety and the Aurora Police Department as they occur. This will ensure we get accurate data and enable evidence to be captured and preserved through neighborhood security equipment and efforts. It takes us all working together!

Community Center Remodeling

The Board has been working with the Murphy Creek Master HOA to improve the Community Center. The Master HOA provided \$76,502 to assist in funding Community Center improvements for all Murphy Creek Metro District 3 residents. As part of the project, the Community Center interior has been repainted, new security cameras have been installed, and a TV has been mounted above the fireplace, along with other audio/visual equipment. Sound absorption panels will also be installed. Be sure to attend a meeting to experience the improvements.

Other 2025 Projects

- Front Range Recreation was hired as our pool services contractor last summer, and operations were improved. New shade structures have been installed on the pool deck to enhance the area's appearance and increase shade availability. But don't worry, there's still plenty of sunny space. New furniture has also been ordered for the pool area.
- The Old Tom Morris Road/Jewell entrance and community center landscape has been approved for refurbishment in the summer of 2025. The work will start at the community center to minimize disruptions to pool users.
- The addition of electronic signage is currently under study, and funding has been approved to repair district fences.

The Board, along with the Manager and Contractors, continues to work on these items and many more to help improve the quality of life and retain property values throughout Murphy Creek. Metro District Board meetings are held at 6:00 on the third Wednesday of each month at the Community Center. Neighbors are encouraged to attend and share their comments and ideas. Security and landscape contractors are present at each meeting to answer questions.

TENNIS/PICKLEBALL COURT UPDATES

Last fall our tennis courts (located across the street from the community center) were resurfaced and pickleball lines were added, along with portable pickleball nets. We are in the process of getting the windscreens secured with sturdier attachments. Because we have suffered frequent instances of vandalism on this community amenity, security cameras have been installed.

We encourage everyone to enjoy the courts for racquet sports only. No pets, bikes, skateboards, rollerblades, cleats, or other things that can harm the court surface. Parents, please make sure your children understand these rules. Let's all have fun!

Murphy Creek Metro District No. 3 Tennis & Pickle Ball Court Rules

1. All use of the tennis courts is unsupervised and at your own risk.
2. Courts are for use by residents and their guests only.
3. Non-skid tennis shoes are required. No Cleats.
4. No pets.
5. No skateboards, rollerblades, skates, or bikes.
6. Other sports, including soccer, futsal or football are not allowed on the courts.
7. No smoking, drugs or alcohol.
8. No glass containers.
9. No disorderly conduct.
10. Play should be limited to one hour if others are waiting to use a court.
11. Access the courts using your amenity keycard. If your keycard doesn't work, please contact the management company at **720-647-6541**.
12. Court hours are from **8 AM to 8 PM**

POOL UPDATES

Over the past year, much of our pool equipment has been repaired and updated and you'll see more improvements in 2025. New shade structures have been added and new furniture is on order. As a reminder, here are the pool rules.

Murphy Creek Metro District No. 3 **POOL RULES & REGULATIONS**

POOL HOURS 10:00AM - 8:00PM

MEMORIAL DAY - LABOR DAY

Lifeguarded hours will change in mid-August

ACCESS: Murphy Creek Metro #3 & their guests only.
Residents must have a valid keycard to gain access into the facility.

GENERAL POOL RULES

1. Proper swim attire required - swim suits only.
2. Children under 14 must be accompanied by a responsible caregiver 18 years of age or older.
3. Limit of two (2) guests per household.
4. Lifeguards will blow the whistle for a 10-minute break every hour.
5. No running or rowdiness in or around the pool is allowed.
6. Non-swimming children must be in direct contact while in the pool with an adult.
7. Large floatation devices and rafts exceeding 4 feet in length are prohibited.
8. No smoking or vaping is allowed.
9. Alcohol and drugs are not permitted.
10. No food or drink can be consumed in the pool.
11. Foul, abusive or excessively loud language is not allowed.
12. Music is allowed but must be kept at a low volume and not include foul language.
13. No glass containers are allowed in the pool area.
14. Murphy Creek Metro #3 and District Staff are not responsible for lost or stolen items.
15. Pets are not allowed in the pool areas or to be tethered to the fence.
16. No diving into the pool is allowed.
17. No scooters, bikes or skateboards are allowed inside the pool area.
18. The wading pool is for children 5 years or under. There is no lifeguard at the wader pool.
19. No person having infectious or communicable disease is allowed in the pool.
20. Pool privileges may be suspended for breaking the pool rules.

Extreme Weather Pool Closures

Conditions warranting closure include lightning, thunder, extreme wind, rain, threatening clouds, tornado warnings, and/or temperatures below 65 degrees. The pool is cleared when lightning is 6 miles away. The deck is cleared when lightning is 3 miles away. Swimming can be resumed once the lightning has been more than 6 miles away for a consecutive 15 minutes. When the temperature is below 65 degrees, FRR will keep the pool closed. If the weather is still unsuitable for swimming at 6:00 PM or if it is determined the weather forecast for the day will prevent the opening of the pool, the pool will be closed for the day.
